

Dear Mrs Boskovich,

I am at present a doctoral research student at the Royal College of Music in London. I am writing to invite you to take part in my doctoral research project.

My project title is: **Intercultural Fusion in the Piano Compositions of Soviet Immigrants to Israel**

I will be studying the piano compositions of 15 Soviet-Israeli composers to identify Russian, Israeli, and other cultural influences in their works. Through an oral history interview with you, I will gather biographical information on your music lives pre- and post-immigration and ask you to identify any influences you have incorporated within your works.

My interview with you will be at most 90-minutes long and will be audio-video recorded (on Zoom or in person). It will be transcribed and sent to you so that you can check and correct the contents. It will then be translated into English. Any relevant sections of my doctorate relating to the interview will be translated into Hebrew.

Participation is entirely voluntary and although I would be delighted to include you in my project, I do understand if you do not wish to participate. Please note that after giving consent, you can still withdraw at any time.

There is a consent form and a recording agreement attached to this letter. If you agree to participate, please complete them. One is a Consent Form, where you agree to be named, interviewed by me, and for the contents to be used in my doctorate and subsequent academic publications. The second is a Recording Agreement that includes permission for the audio and video of our interview to be stored and catalogued at The National Library of Israel (<https://web.nli.org.il/sites/nli/english/infochannels/catalogs/library%20catalogs/pages/aboutmusiccatalogue.aspx>).

During my doctorate I intend to perform a selection of piano pieces by Soviet-Israeli composers in the UK and Israel and will inform you about these performances. I hope that my research will enable this music to reach wider audiences in the UK and Israel.

Additionally, I intend to publish articles that contain material collected from the interviews in peer reviewed journals such as “Min-Ad: Israel Studies in Musicology Online” – <https://www2.biu.ac.il/hu/mu/min-ad/>.

For your information, the Royal College of Music Research Ethics Committee has reviewed my project and granted ethical approval for it to be carried out.




